I. Basic Information of the Project

1. Project overview: <u>Qingdao Metro Line 6 Phase I Project has 21 stations, including Xintun</u> <u>Road Station, Chaoyangshan CBD Station, Huashan First Road Station, Chuangzhigu Station,</u> Shishan Road Station, Huanghai University Station, Harbour Road Station, Chaoyang Road Station, Emeishan Road Station (which has been implemented synchronously with Line 1), Fuchunjiang Road Station, Qiantangjiang Road Station, Binhai University Station, West Qingyi Hospital Station, Gangtou Station, Huanghe Road Station, West Huaihe Road Station, Keluoshi Station, Zhuamashan Station, Heluobu Station, Zhongde Industrial Park Station and Eco-Park Station, with a length of 30.476km. The total building scale of 20 new stations is 329,362 square meters (including station wiring area and property development area).

2. Bidding content: <u>The complete service of supply, installation and supervision,</u> <u>commissioning and acceptance, quality assurance and other services (design, design liaison,</u> <u>design review, prototype acceptance, delivery acceptance, training, etc.) of 144 large fans</u> (including 78 tunnel fans and 66 jet fans), structure matrix type (or structure array type) silencer equipment (304 sets), combined air valve equipment (274 groups) and accessories required for equipment in Phase I Project of Qingdao Metro Line 6 (excluding depot, Emeishan Road Station and main substation).

3. Division: The Project is divided into two bid sections.

Bid Section I: Starting point – Qiantangjiang Road Station (including) (excluding Emeishan Road Station), including 74 large fans, 155 matrix (or array) type silencers and 140 combined air valve equipment;

Bid Section II: Binhai University Station (including) – the end point, including 70 large fans, 149 matrix (or array) type silencers and 134 combined air valve equipment.

II. Requirement shall be met by the prequalification applicants (hereinafter referred to as "Applicant"):

1. Applicant shall be a production and manufacturing enterprise of fan, air valve and silencer with independent legal person status;

2. Applicant shall have at least one completed similar project performance in the last five years;

3. Any subsidiary (company) of the Bidder that does not have the independent legal person status, any legal person providing consulting service for the preliminary work of the Project and any of its subsidiary (company) or any legal person having an interest with the Bidder that may affect the fairness of bidding shall not be eligible to apply for the prequalification; companies with the same principal or companies with holding or management relations shall not apply for the prequalification for the same bid section of the Project at the same time. In case of any of the foregoing circumstances, the Applicant shall negotiate and select one applicant to participate in the prequalification during the period. If the Applicant cannot be selected on time, the Bidder has the right to reject the qualification of the relevant Applicant;

4. The Project is open to all applicants registered in the Member States of New Development Bank; Applicants from the States with appropriate capabilities may apply for the prequalification;

5. The Applicant shall not be an unqualified applicant sanctioned by the host government;

6. The application of distributors and agents will not be accepted by the Project.

III. Bidding Requirements of Consortium

The application put forward by the consortium is accpeted by the Project. If the Applicant is a consortium, the following conditions shall be met

1. The number of members of the consortium shall not exceed 3. Each party in the consortium shall jointly sign a consortium agreement in which the leading party shall be appointed and the scope, rights and obligations of each member shall be specified. The leading party shall be the fan production and manufacturing enterprise, and the members of the consortium shall be combined to meet the requirements of being a fan, air valve and silencer manufacturing enterprise;

2. As a whole, the consortium must meet the requirements of Article 2 of "II. Requirement shall be met by the prequalification applicants (hereinafter referred to as "Applicant")", and each party in the consortium shall meet the requirements of Articles 3, 4, 5, and 6 of "II. Requirement shall be met by the prequalification applicants (hereinafter referred to as "Applicant");

3.Each party in the consortium (including those with the same person as the principal or different companies with holding and management relationships) shall not apply for prequalification in the same bid section in a separate name or participating in a new consortium.

IV. Requirements for Bid Section

The Project is divided into two bid sections, and the Applicant can participate in the pre-qualification application of the two bid sections at the same time, but only one bid section is allowed to win.

V. Methods of Qualification Examination

"Prequalification system with limited quantity" is adopted by the Project. After preliminary review and detailed review, if the qualified applicants of each bid section are below 9 (including), all of them shall participate in the bidding; if there are more than 9 qualified applicants in each bid section, the qualified applicants may be graded by the pre-qualification committee, and the top 9 applicants (if the scores of the 9th applicant are the same) shall be selected to participate in the bidding.

VI. Bid Evaluation Method

"Comprehensive Evaluation Method" is adopted by the Project to determine the pre-winning candidate.

VII. Experience Requirements of Similar Projects

1. The Applicant shall have at least one completed similar project performance in the last five years;

2. When the pre-qualification applicants participate in the prequalification meeting, they shall provide materials to prove the similar engineering experience; otherwise, the pre-qualification applicant will fail in the qualification review or the corresponding scoring items shall not be scored.

3. Definition of similar projects: projects that has the supply performance of axial fan, electric combined air valve and structural silencer, among which the supply amount of axial flow fan single contract is CNY 7 million or above, that of electric combined air valve single contract is CNY 4 million or above, and the supply amount of single contract of structured silencer is CNY 7 million or above. The above similar engineering equipment can be reflected in the same performance contract or in two or more performance contracts respectively.

VIII. Acquirement of Prequalification Documents
