- I. Basic information of the project
- 1. Project overview: Qingdao Metro Line 6 Phase I Project has 21 stations, including Xintun Road Station, Chaoyangshan CBD Station, Huashan First Road Station, Chuangzhigu Station, Shishan Road Station, Huanghai University Station, Harbour Road Station, Chaoyang Road Station, Emeishan Road Station (which has been implemented synchronously with Line 1), Fuchunjiang Road Station, Qiantangjiang Road Station, Binhai University Station, West Qingyi Hospital Station, Gangtou Station, Huanghe Road Station, West Huaihe Road Station, Keluoshi Station, Zhuamashan Station, Heluobu Station, Zhongde Industrial Park Station and Eco-Park Station, with a length of 30.476km. The total building scale of 20 new stations is 329,362 square meters (including station wiring area and property development area).
- 2. Bidding content: <u>Supply of the following equipment and related supporting services: 1. All distribution transformers (46 sets) in the full-line combined substation, step-down substation, and the following step-down substation; 2. Full-line traction rectifier units (32*2750KVA traction transformers and 32*2500KW rectifiers), etc. Please see the user requirements for details.</u>
- II. Requirements for prequalification applicants (hereinafter referred to as "applicants")
- 1. Manufacturing enterprises of transformers with independent legal personality;
- 2. The applicant shall have completed a similar project in the last five years;

- 3. Any subsidiary institution (company) of the bid inviter that does not have independent legal personality, or any legal entity and any subsidiary institution (company) that provides consulting services for the preliminary work of the project, or any legal entity with an interest in the bid inviter that may affect the fairness of the bidding, are not eligible to apply for prequalification of this project. Companies with the same principal or different companies with holding or administrative relationships shall not apply for the prequalification of the project at the same time. In case of any foregoing circumstances, the companies shall negotiate amicably and select an applicant to apply for the prequalification. If the applicant cannot be selected on time, the bid inviter has the right to reject the prequalification qualification of the relevant applicant.
- 4. This project shall be open to all applicants registered in the NDB member states; all applicants from the NDB member states with corresponding abilities can apply for prequalification of this project;
- 5. The applicant shall not be an unqualified applicant sanctioned by the host government;

III. Requirements for consortium bidding

The project does not accept the applications for prequalification from the consortium.

IV. Requirements for bid sections

This project is not divided into bid sections.

V. Methods of qualification examination

The prequalification of the project adopts limited number system. After preliminary examination and detailed examination, all qualified applicants shall participate in the bidding with the number of qualified applicants below 9 (included); the prequalification committee shall score and select the top 9 (if any, the both 9th applicants with the same scores shall be selected) qualified applicants to participate in the bidding with the number of qualified applicants

above 9.

VI. Bid evaluation method

This project adopts "Comprehensive Evaluation Method" to determine the pre-winning bid candidate.

VII. Requirements for experience in similar projects

- 1. The applicant shall have at least completed a similar project performance in the last five years;
- 2. The applicants shall provide materials to prove the similar engineering experience when participating in the prequalification meeting. Otherwise, the prequalification will fail in the qualification review or the corresponding scoring items will not be scored.
- 3.Definition of similar projects: It shall have batch supply performance of AC 35/0.4KV dry-type distribution transformers in construction projects (23 and more in a single supply contract) and batch supply performance of dry-type traction transformers in urban rail transit projects (16 and more in a single supply contract) at the same time. Note: The supply performance of the above dry-type distribution transformers and dry-type traction transformers can be reflected either in the same performance contract, or in two performance contracts respectively.
