### **I. Basic Information of the Project**

1. Project overview: Qingdao Metro Line 6 Phase I Project has 21 stations, including Xintun Road Station, Chaoyangshan CBD Station, Huashan First Road Station, Chuangzhigu Station, Shishan Road Station, Huanghai University Station, Harbour Road Station, Chaoyang Road Station, Emeishan Road Station (which has been implemented synchronously with Line 1), Fuchunjiang Road Station, Qiantangjiang Road Station, Binhai University Station, West Qingyi Hospital Station, Gangtou Station, Huanghe Road Station, West Huaihe Road Station, Keluoshi Station, Zhuamashan Station, Heluobu Station, Zhongde Industrial Park Station and Eco-Park Station, with a length of 30.476km. The total building scale of 20 new stations is 329,362 square meters (including station wiring area and property development area).

2. Contract Scope: Procurement, commissioning and integration services of all equipment in all stations, control centers, vehicle bases and all intelligent operation systems along the line, including BAS & EMS, access control system (ACS), security precaution system and security check system for Qingdao Metro Line 6 Phase I Project. For details, please see the user requirements.

### **II. Prequalification Requirements for Applicants (hereinafter referred to as "Applicant"):**

1. Enterprises with independent legal personality;
2. Applicants shall have at least one completed similar contract in the last five years;
3. Any subsidiary ( affiliated units) of the Purchaser that does not have the independent legal entity status, any legal person providing consulting services for the preliminary preparation of the Project and any of its subsidiary (affiliated units) nor any legal person that has conflict of interest with the Purchaser and may affect the fairness of bidding shall not be eligible to submit an application; Applicants sharing the same person in charge or have the relationship of share-holding or management shall not submit applications for the same contract.
4. Applicants registered in member countries of NDB are invited to submit applications. Applicants from member countries with appropriate capabilities may submit

applications;

5. Applicants shall not be unqualified applicants sanctioned by the government of its country.

### **III. Requirements for Consortiums**

Pre-qualification applications submitted by consortiums are acceptable for this contract. If the applicants are consortiums, the following requirements shall be met:

1. All members of the consortium shall sign a consortium agreement, in which the lead party shall be designated, and the responsibilities, rights and obligations of each member shall be specified;

2. Each party of the consortiums shall meet the above Clauses 1, 3, 4, 5 in "Prequalification Requirements for Applicants"; any party of the consortiums could meet the requirements of Clause 2.

3. Each party of the consortiums (including those in which applicants sharing the same person in charge or have the relationship of share-holding or management) shall not apply for prequalification of the project in its own name or in a new consortium.

### **IV. Requirements for Bid Section**

This contract has one package.

### **V. Methods of Qualification Examination**

The prequalification of the project adopts limited number system. After preliminary examination and detailed examination, if the number of qualified applicants is Nine (9) or less than Nine (9), then all applicants shall participate in the bidding; if the number of qualified applicants is greater than Nine (9), points shall be assigned by the evaluation committee. The first Nine (9) ranked qualified Applications are initially selected. (If any, the ranked 9th applicants shall be selected) to participate in the bidding.

### **VI. Applications Evaluation Method**

"Comprehensive Evaluation Method" is adopted to determine the pre-winning candidates.

### **VII. Experience Requirements of Similar Contracts**

Procurement and integration of integrated monitoring system equipment for urban rail transit project (no less than 11 stations).
