# I. Basic Information of the Project

- 1. Project overview: Qingdao Metro Line 6 Phase I Project has 21 stations, including Xintun Road Station, Chaoyangshan CBD Station, Huashan First Road Station, Chuangzhigu Station, Shishan Road Station, Huanghai University Station, Harbour Road Station, Chaoyang Road Station, Emeishan Road Station (which has been implemented synchronously with Line 1), Fuchunjiang Road Station, Qiantangjiang Road Station, Binhai University Station, West Qingyi Hospital Station, Gangtou Station, Huanghe Road Station, West Huaihe Road Station, Keluoshi Station, Zhuamashan Station, Heluobu Station, Zhongde Industrial Park Station and Eco-Park Station, with a length of 30.476km. The total building scale of 20 new stations is 329,362 square meters (including station wiring area and property development area).
- 2. Contract Scope: Procurement of equipment, facilities and related services, as well as 15-year maintenance service after the expiration of warranty of 260 escalators, 55 elevators, 5 corridor lifts and escalators intelligent operation and maintenance system in the newly built stations and vehicle bases for Qingdao Metro Line 6 Phase I Project. For details, please see the user requirements.

# II. Prequalification Requirements for Applicants (hereinafter referred to as "Applicant"):

- 1. Elevator manufacturers with independent legal personality;
- 2. Applicants shall meet 2.1 and 2.2 prequalification requirements at the same time:
- 2.1 Qualified with the "Manufacture License of Special Equipment of the People's Republic of China" issued by the quality supervision, inspection and quarantine department at the provincial level or above or the "Production License of Special Equipment of the People's Republic of China" issued by the safety supervision department for special equipment at the provincial level or above;

- 2.1.1 For applicants with the "Manufacture License of Special Equipment of the People's Republic of China" issued by the quality supervision, inspection and quarantine department at the provincial level or above, the scope of approval shall include escalators Class B (the maximum lifting height of the escalators that is allowed to be produced shall not be less than 21.76m), passenger elevators without machine room Class A (the maximum rated speed shall not be less than 1.5m/s), traction passenger elevators Class C and above (the maximum rated speed shall not be less than 1.5m/s), traction cargo lifts Class C and above (the maximum rated load shall not be less than 2000kg);
- 2.1.2 For applicants with the "Production License of Special Equipment of the People's Republic of China" issued by the safety supervision department for special equipment at the provincial level or above, the scope of approval shall include escalators (the maximum lifting height of the escalators allowed to be produced shall not be less than 21.76m), passenger elevators without machine room (the maximum rated speed shall not be less than 1.5m/s), traction passenger elevators (the maximum rated speed shall not be less than 1.5m/s), traction cargo lifts (the maximum rated load shall not be less than 2000kg), and the type-test certificate that meets the above requirements shall be provided at the same time;
- 2.2 Qualified with the "Installation, Alteration, Repair & Maintenance License of Special Equipment of the People's Republic of China" issued by the quality supervision, inspection and quarantine department at the provincial level or above or the "Production License of Special Equipment of the People's Republic of China" issued by the safety supervision department for special equipment at the provincial level or above;
- 2.2.1 For applicants with the "Installation, Alteration, Repair & Maintenance License of Special Equipment of the People's Republic of China" issued by the quality supervision, inspection and quarantine department at the provincial level or above, the scope of approval shall include escalators Class B and above, passenger elevators Class C and above, and cargo lifts Class C and above;

- 2.2.2 For applicants with the "Production License of Special Equipment of the People's Republic of China" issued by the safety supervision department for special equipment at the provincial level or above, the scope of approval shall be elevators manufacturing (installation, alteration, repair & maintenance), including escalators, passenger elevators without machine room, traction passenger elevators, traction cargo lifts at the same time.
- 3. The applicants shall have at least one completed similar contract in the last five years;
- 4.Any subsidiary (affiliated units) of the Purchaser that does not have the independent legal entity status, any legal person providing consulting services for the preliminary preparation of the Project and any of its subsidiary (affiliated units) nor any legal person that has conflict of interest with the Purchaser and may affect the fairness of bidding shall not be eligible to submit an application; Applicants sharing the same person in charge or have the relationship of share-holding or management shall not submit applications for the same contract. In case the said circumstances happen, the Applicant shall negotiate and select one applicant to participate in the prequalification. If the Applicant cannot be selected on time, the Purcaser has the right to reject the relevant Applicant for disqualification;
- 5.Applicants registered in member countries of NDB are invited to submit applications. Applicants from member countries with appropriate capabilities may submit applications;
- 6.Applicants shall not be unqualified applicants sanctioned by the government of its country.

#### **III. Requirements for Consortiums**

Pre-qualification applications submitted by consortiums are not acceptable for this contract.

#### V. Methods of Qualification Examination

The prequalification of the project adopts limited number system. After preliminary

examination and detailed examination, if the number of qualified applicants is Nine (9) or less than Nine (9), then all applicants shall participate in the bidding; if the number of qualified applicants is greater than Nine (9), points shall be assigned by the evaluation committee. The first Nine (9) ranked qualified Applications are initially selected. (if any, the ranked 9th applicants shall be selected) to participate in the bidding.

# VI. Applications Evaluation Method

"Comprehensive Evaluation Method" is adopted to determine the pre-winning candidates.

#### **VII. Experience Requirements of Similar Contracts**

- 1. The Applicant shall have at least one completed similar contract in the last five years;
- 2. When applicants participate in the prequalification meeting, they shall provide documentary evidence as proof of similar contractual experience; otherwise, the applicant will fail for the qualification review or the corresponding items shall not be scored.
- 3. Definition of similar contracts: Procurement of escalators for public transport project (the single contract for escalators supply quantity shall be 130 or above).
