# I. Basic Information of the Project

1. Project overview: Qingdao Metro Line 6 Phase I Project has 21 stations,

including Xintun Road Station, Chaoyangshan CBD Station, Huashan First Road Station, Chuangzhigu Station, Shishan Road Station, Huanghai University Station, Harbour Road Station, Chaoyang Road Station, Emeishan Road Station (which has been implemented synchronously with Line 1), Fuchunjiang Road Station, Qiantangjiang Road Station, Binhai University Station, West Qingyi Hospital Station, Gangtou Station, Huanghe Road Station, West Huaihe Road Station, Keluoshi Station, Zhuamashan Station, Heluobu Station, Zhongde Industrial Park Station and Eco-Park Station, with a length of 30.476km. The total building scale of 20 new stations is 329,362 square meters (including station wiring area and property development area).

2.Contract Scope: The AC 400V switch cabinets (531 in total), low-voltage active filter devices and related connecting cables and accessories, etc. in all substations of the main line and metro depot for Phase I of Qingdao Metro Line 6 Project. Please see the user requirements for specific scope of supply and content.

# II. Prequalification Requirements for Applicants (hereinafter referred to as "Applicant"):

- 1.AC 400V switch cabinets manufacturing enterprise with independent legal person qualification;
- 2. If the applicant is an authorized manufacturer, the type of cabinet shall be qualified for the production and manufacturing authorization within the validity period issued by the authorized party; in addition, the applicant shall have the only authorization letter from the authorized party for project bidding. The authorized party and authorized manufacturer shall not participate in the prequalification of this project at the same time;
- 3. Applicants shall have at least one completed similar contract in the last five years (if the applicant is an authorized manufacturer, the authorized manufacturer or its authorized party shall have at least one completed similar contract in the last five years);
- 4. The bid products from the applicant shall have a type test report and be qualified a self-declaration of conformity with compulsory certification;
- 5.Any subsidiary (affiliated units) of the Purchaser that does not have the independent legal entity status, any legal person providing consulting service for the

preliminary preparation of the Project and any of its subsidiary (affiliated units) nor any legal person that has conflict of interest with the Purchaser and may affect the fairness of bidding shall not be eligible to submit an application; Applicants sharing the same person in charge or have the relationship of share-holding or management shall not submit applications for the same bid section. In case the said circumstances happen, the Applicant shall negotiate and select one applicant to participate in the prequalification. If the Applicant cannot be selected on time, the Purchaser has the right to reject the relevant Applicant;

- 6.Applicants registered in member countries of NDB are invited to submit applications. Applicants from member countries with appropriate capabilities may submit applications;
- 7. Applicants shall not be unqualified applicants sanctioned by the government of its country;
  - 8. The application of distributors and agents will not be accepted by the contract.

### **III. Requirements for Consortiums**

Pre-qualification applications submitted by consortiums are not acceptable for this contract.

#### IV. Requirements for Bid Section

This contract has two bid section, Applicants may apply for pre-qualification for both bid segments at the same time, but only one bid section is allowed to win.

# V. Methods of Qualification Examination

The prequalification of the project adopts limited number system. After preliminary examination and detailed examination, if the number of qualified applicants of a bid section is Nine (9) or less than Nine (9), then all applicants shall participate in the bidding; if the number of qualified applicants of a bid section is greater than Nine (9), points shall be assigned by the evaluation committee. The first Nine (9) ranked qualified Applications are initially selected. (if any, the ranked 9th applicants shall be selected) to participate in the bidding.

# VI. Applications Evaluation Method

"Comprehensive Evaluation Method" is adopted to determine the pre-winning candidate.

## VII. Experience Requirements of Similar Projects

- 1. The Applicant shall have at least one completed similar contract in the last five years.
- 2. When applicants participate in the prequalification meeting, they shall provide documentary evidence as proof of similar contractual experience; otherwise, the applicant will fail for the qualification review or the corresponding items shall not be scored.
- 3. Definition of similar contracts: Batch supply performance of AC 400V switch cabinets in construction projects (250 and above in a single supply contract). The type of cabinet specified in the similar performance contract shall be consistent with the type of cabinet that the prequalification applicant intends to bid for (if the applicant is an authorized manufacturer, it is required to provide the similar performance certificate of the authorized manufacturer or its authorized party that meets the requirements of the prequalification document).
